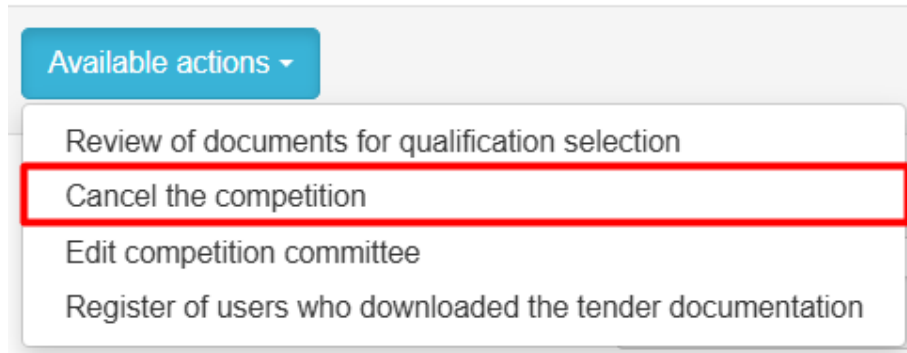


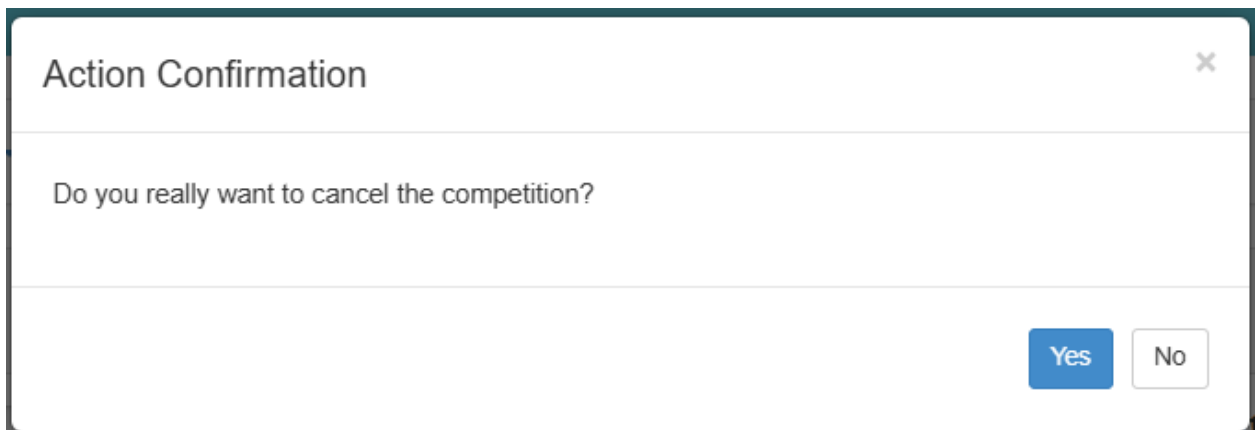
Cancellation of the competition

The competition cancellation functionality is available from the moment the competition is opened until the contracts created.

In order to cancel the competition, the Competition Organizer (Secretary) must select the "Cancel Competition" action in the available actions on the competition preview form.



Cancellation of the competition is possible for the entire competition, as well as for individual lots, if there are several lots in the competition. After performing this action, a warning message is displayed.



When you click on the "No" button, the system returns to the competition viewing form.

To cancel, you need to click on the "Yes" button, after which the System will display a form for selecting lots.

The selection of lots is carried out by putting a tick in the line with the lot, then you need to click on the button "Cancel the competition for selected lots".

You will see a cancellation form where you need to attach a scanned electronic document that is the reason for cancellation and fill in the information on the reason for cancellation.

The competition cancellation form contains the following fields:

Field name	Value
Solution Number	The field is text-based and can be entered manually. In this field, you must specify the report number.
Decision Date	This field indicates the date when the relevant report was issued and is filled in using the "Calendar" icon.
Act	is selected from the position drop-down list in the directory of types of acts with the following values: - Decision - Ruling - Submission

	- Notice - Resolution - Order - Directive .
Authority	In this field, select an organ from the organ directory with the following values: - Judicial authority; - Prosecutor's Office - State Financial Control authority; - Authorized Body - Public Partner - Competition Organizer's Initiative.
The name of the authority	field is text-based and can be entered manually. Enter the full name of the authority in this field.
Solution file	The button is used to attach the document that is the reason for cancellation.

Attention! After filling in all the fields and attaching the file, click on the "Cancel" button. The system will automatically make a decision to cancel the competition/lots .

The action to cancel the competition is displayed in the "Cancel Competition" tab

Note to all: When all lots in the competition are canceled, a minutes is automatically generated on the results of the competition to determine a private partner for a PPP project, indicating the reason for cancellation, at any stage of the competition.

The system automatically changes the previously signed report on results to the current report with information about cancellation.

Note. Competition cancellation is available only when the competition is in one of the following statuses:

- Published (Application Submission);
- Bid Review;
- Review of Bid Additions;
- Generate Admission Minutes;
- Generate Final Competition Minutes for the Selection of the Private Partner under the PPP Project;
- Generate Final Minutes;
- Completed;
- Draft Agreement Approval by the Authorized Body;
- Published (Application Submission) / Qualification Selection;
- Application/Document Additions;
- Qualification Selection.

If the competition is in any other status, cancellation through the System is not available. To request cancellation of the competition, please contact the Authorized Body of the web portal of the Ministry of National Economy of the Republic of Kazakhstan for consideration of your request.
